The bid is to replace the roof and paint the storage building at the Evergreen Cemetery. 5 Ayes, 0 Nay. Motion Carried.

Motion by Trustee Candy Cox, supported by Trustee George Baker to follow through with the motion made in last month's minutes to place an ad in the Shopper's Guide for bids to demolish a building and cleanup a private residential property site.

Girard Township did not receive the court documents in time to place the ad for September. Therefore, a new deadline for all bids, must be submitted by October 31, 2017. Bidder(s) must be Licensed and Bonded.

Motion by Trustee Candy Cox, supported by Treasurer Julie Waterbury to abandon the following grave sites in the Evergreen Cemetery. Section 4 Lot 372, Graves 5,6,7,8 and Section 4 Lot 373, Graves 7,8 and Re-assign 6 new burial sites in a section nearest to the family members involved. The abandon sites are only six feet in length, eight- foot is needed for a full burial. 5 Ayes, 0 Nay. Motion Carried.
