Located next to the public boat launch. Trustee Baker suggested Mr. Rathbun call surveyor Ed Reed to see if he may have something. Meanwhile Supervisor Easterday will talk to Joe Wilkins.

**Motion by** Treasurer Waterbury, Support by Trustee Cox to submit as presented the L-4029 Millage Resolution. Motion Carried.

**Old Business:** Where the Board was with the replacement of the Summer Banner's was the next topic of discussion. Trustee Baker will approach the party involved to attend the July meeting, bringing a few banner/ print samples and pricing before the board in hopes of moving the project forward.
